Scope:

- i) Supply of 01 Unit of Turntable Ladder 70 Meters Working Height (\pm 5 Meters) and 03 Units of Articulated Ladder Platform 32 Working Height for Firefighting & Rescue Purpose in CBU Condition with 03 Years Warranty and Operation & Maintenance Training.
- ii) Supply of 50 units of Fire Tender having capacity of 8,000 Liters Tank (\pm 12.5%), 02 Units Water Tender / Bowser having capacity of 18,000 Liters in CBU Condition with 03 Years Warranty and Operation & Maintenance Training.

All technical bids must be accompanied by Original Bid Security for the amount of Rs.20 Million for Serial No (i) and Rs. 15 Million for Serial No (ii) in the form of Deposit at Call or a Bank Guarantee issued by a Scheduled Bank in Pakistan or from a Foreign Bank duly counter guaranteed by a Scheduled Bank in Pakistan or an Insurance Company having at-least AA rating from PACRA/JCR in favor of KIDCL for a period of 28 days beyond the Bid Validity date.
