The Karachi Infrastructure Development Company Limited (KIDCL), Ministry of Communications, Government of Pakistan invites sealed tender on item rate/ offer rate basis from Interested construction contractors/ firms for the following work, in terms of public procurement rules 2004.;

**Scope:**

**Re- Construction of Mangho Pir Road from Banaras Chowk to Nishtar Road, Karachi.**

**Method of Procurement: Single Stage Two Envelopes, Under Public Procurement Rules, 2004**

3. Documents will be issued from **30th April, 2018** during office hours on payment of a non-refundable tender fee for **Rs 10,000/-**. The tender fee should be in the form of Pay Order in favor of KIDCL. Submission of application for issuance of bid documents along with copy of valid PEC registration certificate in category C1 or above with discipline CE-01 are mandatory.

All technical bids must be accompanied by Original Bid Security for the amount of Rs 20 Million in the shape of Deposit at Call or a Bank Guarantee issued by Scheduled Bank in Pakistan or form a Foreign Bank duly counter guaranteed by a Scheduled Bank in Pakistan or an Insurance Company having at least AA rating from PACRA/JCR in favor of the KIDCL valid for a period 28 days beyond the bid validity date.
