**NOTICE INVITING TENDER**

Sindh Infrastructure Development Company Limited (SIDCL), MoPD&SI, Government of Pakistan, invites sealed bids from scheduled commercial banks for fund management services in relation to the Bus Rapid Transit System (BRTS) Green Line and Orange Line Projects in Karachi, under the Public Procurement Rules 2004.

- The bidding process is open to all scheduled commercial banks/ fund management companies meeting the following basic qualification criteria and other detailed criteria provided in the bidding documents:

Description	Requirement
<b>Eligibility:</b> Reputable and experienced scheduled commercial bank.	
Certification/ Registration: Valid registration certificate from the income tax authority and relevant sales tax authority, if applicable.	To be provided
Minimum credit rating	'AA-'
Volume of cash management (minimum of PKR 1 billion in annual cash management)	Not less than 2 clients

- Open Competitive Bidding will be conducted in accordance with Public Procurement Rules 2004 (**Single-Stage Two Envelope bidding process**), with response time corresponding to national bidding.
- The bidding documents will be issued w.e.f. **28th May 2021** to entities on submission of application on their original letter head along with pay order of PKR. **2500/-** in favour of Sindh Infrastructure Development Co. Ltd (SIDCL).
- Soft copy of the bidding documents may be downloaded from SIDCL website. However, the bidder shall submit pay order of PKR. **2500/-** in favour of SIDCL, at the time of bid submission.
- All technical bids must be accompanied by a bid security for an amount equal to 2.5% of the annual Service Fee issued by a scheduled bank in Pakistan in favour of SIDCL for period of twenty-eight (28) days beyond the bid validity period. The bank issuing the bid security shall always be required to meet the minimum credit rating prescribed under the bidding documents.
- Pre-bid Meeting will be held on **3rd June 2021** (Thursday) at **2:00 p.m.** (Pakistan Standard Time) at the address below. Questions/ queries shall be provided three (03) days in advance (through email or hardcopy at the given address).
- Bid submission date/deadline: **14th June 2021** (Monday) at **3:00 p.m.** (Pakistan Standard Time). Opening of bids at **3:30 p.m.** (Pakistan Standard Time) same day.
