1	Basic Eligibility Criteria: <ol style="list-style-type: none">I. The bidder(s) must have local presence and registered office in Karachi.II. The bidder(s) must be tax-payer having National Tax Number and General Sales Tax.III. The bidder(s) must provide after sales support up to 1 year.IV. Discontinued models will not be acceptable.V. Joint ventures are not allowed.VI. Affidavit on judicial stamp paper that the supplier is not blacklisted/ defaulted by any of Provincial or Federal Government Department, Agency, Organization or autonomous body or Private Sector Organization anywhere in Pakistan.VII. Provide separate undertaking that the information supplied by the supplier is correct.

Method of Procurement: Single Stage - One Envelop Procedure under Public Procurement Rules 2004

3. Documents will be issued from 17 March, 2022 during office hours, on payment of a non – refundable proposal fee of Rs. 500/- (Five Hundred Only). The fee should be in the form of Pay Order in favor of Sindh Infrastructure Development Company Limited.
4. Soft Copy of the Tender Document may be downloaded from SIDCL website. The bidder shall then submit it hard copy along with the pay order of Rs 500/- in favor of Sindh Infrastructure Development Company Limited.
5. All bids must be accompanied by Bid Security in an amount equal to at least 2% percent of the Bid price, in Pakistani Rupees in the shape of Pay Order in favor of SIDCL for a period of 28 days beyond the bid validity date. (Bid Validity is 90 days)
